Connecticut Water Supports Energy-Conservation Projects at the Killingworth Library *Company Provides Funding for Energy Efficiency Projects through Neighborhood Assistance Act*

KILLINGWORTH, Conn. — Dec. 17, 2018 — Connecticut Water Company is proud to announce that it is helping to fund energy-conservation projects at the Killingworth Library through the Connecticut Neighborhood Assistance Act tax credit program. Five paid staff members are backed up by a corps of dedicated volunteers who manage the circulation desk and provide board governance, maintenance and operational support.
