



School Water Bottle Filling Station 2023 Grant Program

Connecticut Water provides safe, reliable drinking water to schools within our service area and ensures students, faculty and staff have access to safe drinking water to provide the hydration needed for learning and activities throughout the day. We encourage the use of tap water to reduce plastic waste in our landfills and eliminate environmental costs of bottling/transporting packaged water.

Connecticut Water's School Water Bottle Filling Station Grant Program has been established to assist and encourage schools that are served by Connecticut Water to adopt a more sustainable approach and provide students and staff access to safe, reliable and convenient tap water to refill personal, refillable bottles.

Funding will be awarded for up to 10 water bottle filling stations in our service communities, or a total of \$15,000 each calendar year. Only one water bottle filling station may be awarded per eligible school. Funding is provided by Connecticut Water's Charitable Giving program and is not recovered in customer rates. Eligibility

Applicant must be an accredited school located within Connecticut Water's service area, and have a service connection with Connecticut Water for domestic water supply.

Criteria for Participation

- 💧 The proposed location of the station must be in a visible area and easily accessible to students and staff.
- 💧 Applicant assumes responsibility for installation and maintenance as recommended by the manufacturer.
- 💧 The applicant agrees to coordinate a photo opportunity post-installation, with subsequent use including, but not limited to, social media.
- 💧 Installation of the station must occur within 180 days from the application approval date.
- 💧 Projects must not have started prior to application approval.

Application Requirements

- 💧 Completed Application Form
- 💧 Photo or sketch of proposed location of the unit
- 💧 Specify the Unit requested from the approved model list, and delivery address.
- 💧 Signed and completed Federal W-9 Tax Form
- 💧 Copies of any required permits for the installation

Application Deadline

Applications are due by **January 31, 2023**. Grant recipients will be notified in February 2023, and will have 180 days to install the fill station unit. Incomplete applications will not be considered; please be sure to provide a contact name for any follow-up questions we may have, and also the personnel to contact to arrange delivery.

Approved Models and Delivery

Connecticut Water's supplier offers new installation or retrofit units. Connecticut Water will order the unit and deliver the unit to the recipient facility, to be arranged on a per-case basis. Connecticut Water will pay the supplier directly.
