Water Service Rates are set
by the Connecticut Public Utilities
Regulatory Authority (PURA).

Effective 1/1/2026



The charges for all customers include a **Basic Service Charge**, **Water Usage Charge** and **PURA-Approved Surcharges or Credits**.

- **Basic Service Charge** covers the cost associated with basic operation, billing and customer service. This charge is based on the meter size on your account. These Basic Service Charges are applied even if there is no consumption at a premise during a particular billing period.
- **Water Usage Charge** is based on the number of gallons, or cubic feet used, multiplied by the approved rate. This charge shows on the bill in units of gallons or cubic feet depending on how the meter installed at your premises records the usage. Water usage charges are also subject to a Water Conservation Rate. See table for more information.
- **PURA-Approved Surcharges or Credits** are applied on a percentage basis to the total of the Basic Service Charge and Water Usage Charge as noted below:
 - **Water Infrastructure and Conservation Adjustment (WICA)** recovers the costs for eligible infrastructure replacement projects and certain conservation related expenses. This charge may be adjusted every six months.
 - **Water Revenue Adjustment (WRA)** ensures that water utilities do not over-collect or under-collect the revenues that were approved in rates by PURA. This charge is reviewed annually and may be a charge or credit on customers' bills based on actual revenues collected in the prior year. WRA is also applied to miscellaneous service charges and service fees.
 - The **Water Quality & Treatment Adjustment (WQTA)** recovers the cost of implementing treatment for new EPA regulations, such as those for removing PFAS from drinking water, between rate cases. This charge may be adjusted every 12 months.



Most Connecticut Water customers are billed quarterly, though some are billed monthly. The number of days in a billing cycle may vary slightly, but your **Basic Service Charge** and **Water Usage Charge** reflect the actual usage and days in the billing period for your account.
